Introduction

This report has been produced by Johnson Fellows on behalf of the Landlord, PR Trinity Investments Ltd. It is intended to provide details of the planned expenditure for the service charge period 1st January 2026 to 31st December 2026.

Enclosed within this report is a copy of the Service Charge Variance Schedule and Service Charge Apportionment Schedule.

The service charge is administered having regard to the RICS Professional Statement; Service Charges in Commercial Property; 1st Edition.

The Property

The property is located on Grammar School Lane, which adjoins Old Hawne Lane. The property is a short distance from the A458 Stourbridge Road and the main Halesowen town centre.

Borough Court is a courtyard style development providing a mixture of single and two storey buildings of varying ages. There are a variety of uses including offices, light industrial and a gymnasium. In addition to the courtyard buildings, there is an adjacent plot of land used for display purposes.

The communal areas of the estate include the car park and rear walkways. Under the terms of the individual leases, the maintenance of the roof and building structure is also provided for under the service charge provisions.

Voids and Concessions

Where any void units exist, the responsibility for the service charge rests with the Landlord.

VAT

The property is elected for VAT, consequently the expenditure stated within this report is net of VAT.

Banking

Due to the general level of service charge funds, they are not maintained within a discrete bank account. The funds are held within the Johnson Fellows Clients Account which is maintained with Barclays Bank plc. The service charge is not credited with any interest, neither are any bank charges allocated to the service charge.

Interest charged on the late payment of service charge by tenants is to be credited to the service charge.

Reserve Fund

A Reserve Fund was introduced in 2016. The Reserve Fund is held in a discrete bank account to obtain interest on the retained funds. The fund as the December 2024 currently £9203. Approximately £4K of this sum will be allocated toward roof repairs undertaken within the



service charge year ending December 2025. The reserve fund will continue to be maintained and utilise against major items of expenditure in the future as required.

Service Charge Objectives

The objective of Johnson Fellows as Managing Agent is to provide a quality management service. In so doing we aim to provide a well-maintained environment, delivering value for money for the service charge expenditure.

The objective of this budget report is to provide a clear explanation for recovery of the service charge expenditure on a not for profit/not for loss basis. It is also to promote clarity and transparency and to allow the tenants to budget accurately for the forthcoming period.

Should any occupier have comments on the format, or the information contained in this report which would assist in the report being improved for the benefit of all concerned, these comments would be welcomed. We would also welcome constructive feedback on the communal services provided at the property.

Service Charge Apportionment

The apportionment is detailed within the Service Charge Apportionment Schedule attached at Appendix A.

The service charge expenditure is contained under a single schedule that all courtyard occupiers contribute towards, reflecting the benefit of the services provided. The occupier of the adjacent land does not contribute towards the service charge.

The apportionment percentages are calculated based on net internal floor areas in the individual units.



Budget Commentary

SCHEDULE 1 – All Courtyard Occupiers

All figures are shown net of VAT

- **External Cleaning** **£1,500**

This heading reflects the cost of the contract for litter picking, sweeping, weed control and the removal of any fly tipping across the main car park and the rear fire escape routes.

- **Landscaping** **£1000**

The cost heading provides for the annual pruning beech trees and vegetation around the estate to include the provision of access equipment and the removal of debris.

- **Refuse** **£2,550**

The budget provides for the weekly waste collection tenant's refuse and recycling. There are 3 bins, 2 for general waste and 1 for recycling. Incorporated within this cost heading is a contribution for Landfill Tax.

- **Building Repairs** **£8,000**

The budget provides for the cost of any repairs and maintenance works in respect of the structure and roofs of the buildings together with any maintenance required to the car park. This heading has been increased this year to reflect expenditure incurred in 2025 and to make provision for any repairs that maybe required within this financial year.

- **Water Charges** **£1,000**

The cost heading provides for the water charges levied at the estate in respect of metered water and metered sewerage. Surface water charges are payable by individual unit holders based on rateable value.

- **Gritting** **£980**

The budget allows for the anticipated costs incurred in gritting the car park during the winter months. The budget has been increased based on the current year's expenditure.



- **Health & Safety** **£500**

The cost heading will allow for the provision of an updated Health and Safety Audit. This is recommended best practice to ensure that the site meets current regulations.

- **Reserve Fund** **£1,000**

A Reserve Fund has been set up to accrue funds for major items of expenditure required to the estate and buildings. The Reserve Fund is aimed at meeting anticipated future costs of maintenance to avoid fluctuations in any particular year. Part of the reserves was utilised last year in respect of roof repair works required to the buildings. The contribution for the new year has been maintained at the same level.

- **Audit Fee** **£350**

The RICS Service Charge Code of Practice states that service charge accounts are to be independently certified on an annual basis. This cost covers the fee raised by the accountants for certifying the year end service charge accounts.

- **Management Fee** **£2,311.14**

The figure represents the costs incurred for the management of the property and the administration of the service charge, including periodic inspections. The RICS Service Charge Code of Practice recommends that this be a fixed fee. The fee has been increased for the current year in line with the Retail Price Index.

- **Facilities Management** **£1155.57**

The budget cost is for the Facilities Manager to organise and supervise the service charge contracts, maintenance works and ensure legislative compliance. The fee has been increased for the current year in line with the Retail Price Index.).
